CERTIFICATE OF WATER RIGHT

This Is to Certify, That ERNEST R. CRAMER

of Route 1, Box 175, Hermiston, State of Oregon 97838, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Columbia River for the purpose of irrigation of 132.8 acres

under Permit No. G-1322 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 11, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.30 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 10, T3N, R26E, WM; 1,380 feet North and 1,320 feet East from SW Corner, Section 10 (shown on Certificate 31194 as 75 feet North and 20 feet East from Center of SW $\frac{1}{4}$).

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

26.0 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$	25.9 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$
20.9 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$	14.3 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$
20.5 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$	Section 10
25.2 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$	Township 3 North, Range 26 East, WM


This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 34276, Volume 26, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on March 19, 1981, approving Transfer Application 4686.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
