CERTIFICATE OF WATER RIGHT

This Is to Certify, That the ESTATE OF GEO. GEKELER, by C.R. GEKELER

of LaGrande, State of Oregon, has
a right to the use of the waters of Grande Ronde River and Gekeler Slough

a tributary of irrigation of 206.0 acres for the purpose of

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 373; that the priority of the right thereby confirmed dates from 1883 for Grande Ronde River, and 1869 for Gekeler Slough

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed three acre-feet per acre in any irrigation season, diverted at a rate of not to exceed one-fortieth of a cubic foot per second per acre,


This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 20230, Volume 14, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on November 25, 1980.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
