## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

JACK C. CAMPBELL

of Box 57, Summit Star Route, Blodgett a right to the use of the waters of two springs

, State of Oregon 97326 , has

a tributary of Marys River for the purpose of domestic use for one family, irrigation of 1.4 acres and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Benton County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 18, at page 367; that the priority of the right thereby confirmed dates from 1900

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second being 0.005 cfs for domestic and 0.02 cfs for irrigation from west spring and 0.005 cfs for stock from east spring.

The point of diversion is located in the SW4 SE4, SE4, Section 32, T10S, R7W, WM; West Spring - 1070 feet North and 1030 feet East; East Spring - 1170 feet North and 1540 feet East; both from S4 corner, Section 32.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

0.3 acre NE¼ SW¼ SE¼ Domestic, Stock & 1.1 acres NW¼ SE¼ SE¼ Section 32 Township 10 South, Range 7 West, WM

Beginning at a point in the center of County Route #55 as same existed February 1, 1967, which point is Northerly along said centerline 280 feet from the intersection of said centerline and the South line of Section 32, Township 10 South, Range 7 West, Willamette Meridan, Benton County, Oregon and run thence West, parallel with the South line of said Section 32, to the North-South center line of said Section 32; thence Northeasterly 1480 feet, more or less, to a point 600 feet West of a point on the West right of way line of County Route #55, which last mentioned point is 640 feet Southerly along the West right of way line of said County Route #55 from its intersection with the North boundary line of that tract conveyed to David E. Lister, et ux, by deed recorded January 3, 1952 in Deed Book 137, page 407, records of Benton County, Oregon; thence East, parallel to the East-West centerline of said Section 32, 630 feet, more or less, to the center of said County Route #55; thence Southerwesterly, along the center of said County Route #55 to the point of beginning, in the County of Benton and State of Oregon.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
