CERTIFICATE OF WATER RIGHT

This Is to Certify, That HARLEY W. & BETTY HUFF

of 08087 Fiddle Creek Road, Westlake, State of Oregon 97493, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Fiddle Creek

a tributary of Siltcoos Lake for the purpose of irrigation of 34.4 acres

under Permit No. 39755 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 24, 1973 for 0.06 c.f.s.; October 25, 1974 for 0.11 c.f.s. that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.17 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 34, T19S, R11W, WM; Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$); Lot 2 (NW $\frac{1}{4}$ NE $\frac{1}{4}$), Section 3, T20S, R11W, WM; 80 feet North and 4820 feet West; 530 feet South and 870 feet West; 290 feet South and 2420 feet West; all from NE corner, Section 3, T20S, R11W, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.3 acre SE $\frac{1}{4}$ SE $\frac{1}{4}$

2.4 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$

3.8 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$

1.0 acre SW $\frac{1}{4}$ SE $\frac{1}{4}$

1.5 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$


