CERTIFICATE OF WATER RIGHT

This Is to Certify, That ELMER H. SCHNEIDER

of Route 2, Box 171, Woodburn, State of Oregon 97071, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Schneider Reservoir constructed under Permit R-5016

a tributary of Rock Creek for the purpose of supplemental irrigation of 6.6 acres and fish culture

under Permit No. 32650 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 1, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.8 acre-feet stored water only, being 3.1 acre-feet for irrigation and 1.7 acre-feet for fish culture,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 18, T5S, R1E, WM; 130 feet South and 2,440 feet East from W $\frac{1}{4}$ Corner, Section 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to -----of one cubic foot per second per acre, a diversion of 2 $\frac{1}{2}$ acre-feet per acre for each acre irrigated during the irrigation season of each year and shall be further limited to a total diversion of not to exceed 3.1 acre-feet per year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Fish culture and 4.1 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
2.5 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 18
Township 5 South, Range 1 East, WM


This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 43741, Volume 35, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on July 21, 1981.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
