## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

RAY W. REYNOLDS

of 7589 Takilma Road, Cave Junction , State of Oregon 97523 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a sump

a tributary of Little Elder Creek for the purpose of irrigation of 4.8 acres and supplemental irrigation of 2.2 acres

under Permit No. G-3507 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 19, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.09 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE% SE%, as projected within Sutherland DLC 44, Section 23, T40S, R8W, WM; 590 feet South and 100 feet West from the Interior Ell Corner, Sutherland DLC 44.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre-feet per acre for each acre irrigated during the irrigation season of each year; and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
