## CERTIFICATE OF WATER RIGHT

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Malheur County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at page 258; that the priority of the right thereby confirmed dates from 1871 for irrigation of 90 acres from Willow Creek; 1879 for irrigation of 14.5 acres from South Fork of Willow Creek; 1880 for\* that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.87 cubic feet per second from April 1 to May 1 and 2.95 cfs from May 1 to September 1 of each vear, or the equivalent in case of rotation; the total quantity diverted during each irrigation season not to exceed 703.5 acre-feet.
