CERTIFICATE OF WATER RIGHT

This Is to Certify, That FREDERICK C. HERRING

of 717 Sheriden Street, Newberg , State of Oregon 97132 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Williamson Creek and reservoir constructed under Permit R-1309

a tributary of Chehalem Creek irrigation of 88.8 acres

for the purpose of

under Permit No. 20999 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 31, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.726 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW_4 SE $_4$, as projected within Williamson DLC 46, Section 14, T3S, R3W, WM; 2,030 feet North and 450 feet West from SE Corner, Williamson DLC 46.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-1309,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
