CERTIFICATE OF WATER RIGHT

This is to Certify, That Stubblefield Ditch Company

of Enterprise , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Hurricans Creek a tributary of Wallows River for the purpose of irrigation, domestic & stock under Permit No. 3279 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 10. 1917;

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

2.14 cubic feet per second;

The use hereunder for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent in case of rotation.

A description of the lands irrigated under the right hereby confirmed, and to which such right is appurtenant (or, if for other purposes, the place where the water is put to beneficial use), is as follows: Thirty (30) acres in the Southeast Quarter of the Northeast Quarter (SETET), Forty (40) acres in the Northeast Quarter of the Southeast Quarter (NETSET), Nineteen and 8/10 (19.8) acres in the Southeast Quarter of the Southeast Quarter (SETET) of Section Eleven (11); Thirty (30) acres in the Southwest Quarter of the Southwest Quarter (SETET) of Section Eleven (11); Eighteen (18) acres in the Northwest Quarter of the Northwest Quarter (SETET), Sixteen (16) acres in the Southwest Quarter of the Northwest Quarter (SETET) of Section Thirteen (13); Seven (7) acres in the Northeast Quarter of the Northeast Quarter of the Northeast Quarter (SETET) of Section Fourteen (14), Township Two South, Range Forty-four East of the Willamette Meridian, in Wallowa County, Oregon, being a total of 160.8 acres.

(Note: The right hereby confirmed for 30 acres in the SE2 NE2 Section 11, Twp. 2 S., R. 44 E., W. M., is supplemental to rights heretofore acquired from Wallowa River and Little Hurricane Creek.)

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
