## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** BILL L. ROSE

of 17236 Butteville Road, Woodburn, State of Oregon 97071, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Bill L. Rose Reservoir constructed under Permit R-5821

a tributary of Rock Creek for the purpose of irrigation of 311.9 acres and supplemental irrigation of 58.0 acres

under Permit No. 35975 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 1, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 339.3 acre-feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 SE 1/4, Section 17, T5S, R1E, WM; 1,220 feet North and 1,220 feet West from SE Corner, Section 17

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~of one cubic foot per second per acre~~ a diversion of 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


