## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

HOWARD L. BROWNSON

of Myrtle Creek , State of Oregon 97457 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Myrtle Creek

a tributary of South Umpqua River irrigation of 62.2 acres

for the purpose of

under Permit No. 19302 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 14, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.75 cubic foot per second, if available at the original point of diversion, NE 1/4 NW 1/4, as projected within H. Weaver DLC 39, Section 21, T29S, R4W, WM: 1,400 feet North and 3,200 feet West from E 1/4 Corner, Section 21,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NW 1/4 and SW 1/4 NE 1/4, both as projected within H. Weaver DLC 39, Section 21, T29S, R4W, WM; Number 1 - 1,400 feet North and 3,200 feet West, and Number 3 - 1,300 feet North and 2,040 feet West, both from E 1/4 Corner, Section 21

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm an additional point of diversion approved by orders of the Water Resources Director entered August 31, 1970 and January 19, 1981, and together with certificates of water right recorded at page 50482 and 50483 , Volume 44 , State Record of Water Right Certificates, supersedes certificate of water right recorded at page 20541, Volume 15.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
