CERTIFICATE OF WATER RIGHT

This Is to Certify, That WALLACE F. CAMPBELL

of Route 1, Box 194, La Grande, State of Oregon 97850, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of John Day River

a tributary of Columbia River for the purpose of irrigation of 9.8 acres

under Permit No. 28944 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the rights hereby confirmed dates from June 25, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, Section 20, T13S, R29E, WM; 520 feet North and 640 feet East from W 1/4 Corner, Section 20

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of the John Day River is more than 30 cfs at USGS Gage 14-0465 and more than 20 cfs at USGS Gage 14-0480,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.4 acres SE 1/4 NE 1/4	3.0 acres SW 1/4 NW 1/4
0.4 acre NE 1/4 SE 1/4	3.0 acres NW 1/4 SW 1/4
Section 19	Section 20
Township 13 South, Range 29 East, WM	


This certificate describes that portion of the water right confirmed by the order of the Water Resources Director recorded at page 606, Volume 34, Special Order Record entered on June 17, 1981, approving Transfer Application 4745, NOT modified by the provisions of said order.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
