## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** ALDER CREEK RANCH

of PO Drawer U, Grass Valley, State of CALIFORNIA 95945, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Viewpoint Wells 1, 2 and 3

a tributary of Ana River for the purpose of irrigation of 441.2 acres

under Permit No. G-697 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 14, 1957 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.52 cubic feet per second, being 2.77 cfs from Well 2, 0.90 cfs from Well 1, and 1.85 cfs from Well 3

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW 1/4 SW 1/4 Section 18, SW 1/4 SE 1/4, Section 19, SE 1/4 NW 1/4, Section 29, T27S, R19E, WM; 3,260 feet North and 80 feet East, 2,320 feet South and 2,710 feet East, both from the W 1/4 Corner, Section 19, 2,110 feet East and 2,660 feet North from the SW Corner, Section 29

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


