## CERTIFICATE OF WATER RIGHT

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8, at page 119; that the priority of the right thereby confirmed dates from 1855 for Tract 1 (irrigation and stock); 1882 for Tract 2 (irrigation and domestic); 1908 for Tract 3 (irrigation); and 1855 for\* that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth of one cubic foot per second for each one thousand head of stock, a reasonable amount for domestic purposes, and one-sixtieth of one cubic foot per second per acre during the irrigation season from April 1 to October 1, if available at the original points of diversion; NE 1/4 NW 1/4, Section 23, T1N, R12E, \*\*

The point of diversion is located in the SW 1/4 SE 1/4, Section 14, T1N, R12E, WM; Tracts 1, 2, and 3 - 110 feet North and 1,860 feet West from SE Corner, Section 14.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

\* land irrigated from spring;

\*\* WM; Tract 1: Sandoz Ditch - 290 feet South and 2,850 feet West, Tract 2: Brace Ditch - 880 feet South and 3,762 feet West, both from the NE Corner, Section 23.
