CERTIFICATE OF WATER RIGHT

(For rights perfected under original, enlargement or secondary permits)

This is to Certify, That W. F. KING, OLIVER POWELL and ARTHUR R. MINNLER

of Prineville, State of Oregon, has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the waters of Ochoco Creek, a tributary of Crooked River

for the purpose of the irrigation of four hundred and twenty-five acres of land under Enlargement Permit No. 24 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered

of record in the Record of Proceedings of said Board, at Salem, in Volume 1, at page 160, on the 17th day of July, 1914; that the priority of

the right hereby confirmed dates from December 1, 1909; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not

exceed 5.32 cubic feet per second, or its equivalent in case of rotation. The use hereunder shall conform to any reasonable rotation system ordered by the proper state officer. A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

40 acres in the NE 1/4 SE 1/4; 40 acres in the NW 1/4 SE 1/4; 40 acres in the SW 1/4 SE 1/4; 40 acres in the SE 1/4 SE 1/4; in Section Thirty (30): 40 acres in the NE 1/4 SE 1/4; 40 acres in the NW 1/4 SE 1/4; 15 acres in the SE 1/4 SE 1/4; 40 acres in the NE 1/4 SW 1/4; in Section Thirty-two (32): 5 acres in the NE 1/4 NE 1/4; 12 acres in the SW 1/4 NE 1/4; 25 acres in the SE 1/4 NE 1/4; in Section Twenty-eight (28): 5 acres in the NE 1/4 SW 1/4; 20 acres in the NW 1/4 SW 1/4; 40 acres in the SW 1/4 SW 1/4; 25 acres in the SE 1/4 SW 1/4; in Section Twenty-six (26): all in Township Fourteen (14) South Range Sixteen (16) East of Willamette Meridian.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
