## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**      THOMAS BLANCHARD

of 22700 Barba Road, Beaver      , State of Oregon 97108 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of spring-stream and Nestucca River

a tributary of Pacific Ocean      for the purpose of domestic use for one family including the irrigation of lawn and garden not to exceed one-half acre in area and irrigation of 9.2 acres under Permit No. 41346      and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the rights hereby confirmed dates from January 27, 1977 for 0.01 cubic foot per second for domestic and March 3, 1977\* that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.13 cubic foot per second; being 0.01 cfs from the spring-stream for domestic use and 0.12 cfs for irrigation from Nestucca River for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SW 1/4, Section 24; NW 1/4 NW 1/4, Section 25, T3S, R9W, WM; spring-stream -- 850 feet North and 540 feet East; river -- 200 feet South and 530 feet East, both from SW Corner, Section 24

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:



The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
