## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

WILLIAM MORGAN SOPER

of PO Box 276, Enterprise , State of Kansas 6744l , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of four wells

a tributary of Simpson Creek for the purpose of irrigation of 1.69 acres, supplemental irrigation of 17.83 acres and frost control and harvesting of cranberries for 19.52 acres under Permit No. G-6783 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 19, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.44 cubic foot per second, being 0.44 cfs for each use

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the  $\,$  NW 1/4 NE 1/4, Section 29, SW 1/4 SE 1/4, Section 20, T28S, R14W, WM; Well 1 - 600 feet South and 750 feet East, Well 2 - 550 feet South and 1,260 feet East, Well 3 - 200 feet South and 1,200 feet East, Well 4 - 50 feet North and 1,240 feet East all from N 1/4 Corner, Section 29

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall be further limited to appropriation \* and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

\* of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others
