CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DR. WILLIAM M. SOPER, DDS

of PO Box 276, Enterprise , State of Kansas 67441 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Simpson Creek and three ponds constructed under Permit R-5809

a tributary of Coquille River for the purpose of supplemental irrigation of 6.4 acres and frost control for 15.33 acres

under Permit No. 35941 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 9, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.30 cubic feet per second, being 0.08 cfs for supplemental irrigation and 2.30 cfs for frost control

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $\,$ NW 1/4 SE 1/4, SW 1/4 SE 1/4, Section 20, NW 1/4 NE 1/4, Section 29, T28S, R14W, WM; Simpson Creek-820 feet South and 980 feet East from C 1/4 Corner, Section 20; Holding Pond 1-835 feet North and 325 feet East; Holding Pond 2-195 feet North and 505 feet East; Holding Pond 3-490 feet South and 740 feet East, all from the S 1/4 Corner, Section 20

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-5809, for cranberries.*

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

* If for the irrigation of any other crop, this appropriation shall be limited to the use of stored water only and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year, the use of stored water only on the lands described as supplemental
