of Post , State of Oregon 97752, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Crooked River

a tributary of Deschutes River irrigation of 77.3 acres

for the purpose of

under Permit No. 29717 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 4, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.93 cubic feet per second total measured at points of diversion

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NE 1/4, Section 30, SW 1/4 NE 1/4, Section 34, SW 1/4 SW 1/4, Section 36, T16S, R19E, WM; Diversion 5-1,590 feet South and 1,050 feet West from NE Corner, Section 30, Diversion 4-1,550 feet South and 2,130 feet West from NE Corner, Section 34, Diversion 3-1,150 feet North and 190 feet East from SW Corner, Section 36

feet North and 190 feet East from SW Corner, Section 36

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre,

or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
