CERTIFICATE OF WATER RIGHT

This Is to Certify, That

CLYDE HOLIDAY

of Star Route, John Day , State of Oregon 97845 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Pine Creek and a Swale

a tributary of John Day River for the purpose of irrigation of 26.4 acres and supplemental irrigation of 48.0 acres

under Permit No. 34271 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 28, 1969

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.86 cubic feet per second, being 1.19 cfs from Pine Creek and 0.67 cfs from Swale

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SW 1/4, Section 36, SW 1/4 NW 1/4, NW 1/4 SW 1/4, Section 26, T13S, R32E, WM; Pine Creek - 3,030 feet South and 1,800 feet East from NW Corner, Section 36; Swale - Diversion 4: 2,750 feet North; Diversion 3 - 2,000 North and 320 feet East both from SW Corner, Section 26

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
