## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**TALL TIMBER RANCH  
FOUNDATION OF HUMAN UNDERSTANDING

of 1980 Deer Creek Road, Selma, State of Oregon 97538, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Salt Gulch Creek, Tall Timber Reservoir 1, constructed under Permit R-4608, and Tall Timber Reservoirs 2, 3, and 4, constructed under Permit R-6320 a tributary of Deer Creek for the purpose of irrigation of 10.7 acres and supplemental irrigation of 28.1 acres

under Permit No. 39459 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 16, 1974

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.21 cubic foot per second and stored water only from Reservoirs 1, 2, 3 and 4

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SW 1/4, SW 1/4 NW 1/4, NW 1/4 NW 1/4, Section 7, T38S, R7W, WM: Reservoir 1 - 360 feet South and 570 feet East; Reservoir 2 - 400 feet North and 1,220 feet East; Reservoir 3 - 840 feet North and 1,200 feet East; Reservoir 4 - 1,660 feet North and 1,240 feet East, all from W 1/4 Corner, Section 7.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fiftieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoirs constructed under Permits R-4608 and R-6320 and shall be further limited to the use of stored water only on the lands described as supplemental

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


In processing the application towards issuance of the permit, it appears that a clerical error was inadvertently made in limiting the duty of water to not exceed one-eightieth of one cubic foot per second per acre and 3 1/2 acre-feet per acre. In the issuance of this certificate, the duty of water has been raised to one-fiftieth cfs per acre and 3 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year, in keeping with the customary policy and determination of this office of proper maximum limits.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board*
