CERTIFICATE OF WATER RIGHT

This Is to Certify, That

HOMER L. GOULET

of 10612 Wheatland Road, Gervais , State of Oregon 97026 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells

a tributary of Willamette River for the purpose of irrigation of 113.0 acres and supplemental irrigation of 41.0 acres

under Permit No. G-7240 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 22, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.55 cubic feet per second, being 0.55 cfs from Well 1 and 1.0 cfs from Well 2

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE 1/4 SE 1/4, SE 1/4 NE 1/4, Section 13, T6S, R3W, WM; Well 1 - 650 feet South and 1,250 feet West, Well 2 - 1,320 feet North and 650 feet West, both from E 1/4 Corner, Section 13

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second $per\ acre$, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
