CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of 56/4 Buyserie Road, NE, St. Paul , State of Oregon 9713/, hus made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Mission Creek and Mission Creek Dam and Reservoir Company Reservoir constructed under Permit R-5667

a tributary of Champoeg Creek for the purpose of irrigation of 151.8 acres and supplemental irrigation of 70.8 acres

under Permit No. 35330 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 15, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.8 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 7 (SE 1/4 SE 1/4), Section 8, T4S, R2W, WM; Dam - South 85 degrees West 380 feet from NW Corner, Pettier DLC 92.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoirs constructed under Permit R-5667

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
