This Is to Certify, That ALDER CREEK RANCHES, INC.

of PO Drawer U, Grass Valley, State of California 95945, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wells 6, 10 and 14

a tributary of Fort Rock Basin for the purpose of irrigation of 114.0 acres

under Permit No. G-8988 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 3, 1980 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.42 cubic feet per second; being 0.08 cfs from Well 6, 1.09 cfs from Well 10 and 0.25 cfs from Well 14

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW 1/4 NE 1/4, Section 19, Well 6 - 2,120 feet South and 1,910 feet West from NE Corner, Section 19; SE 1/4 NE 1/4, Section 20, Well 10 - 1,620 feet South and 1,070 feet West from NE Corner, Section 20; SW 1/4 SE 1/4, Section 21, Well 14 - 930 feet North and 1,570 feet West from SE Corner, Section 21, T27S, R19E, WM

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


