CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRED DRESCHER

of 34078 South Meridian Road, Woodburn, State of Oregon 97071, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Drescher Creek and reservoir constructed under Permit R-1943

a tributary of Butte Creek for the purpose of irrigation of 96.5 acres

under Permit No. 41820 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the rights hereby confirmed dates from March 7, 1977 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.21 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NE 1/4 as projected within Newman DLC 73, Section 25, T5S, R1W, WM; SW 1/4 NW 1/4, Section 30, T5S, R1E, WM; 1 - 1,010 feet South and 430 feet West; 2 - 2,210 feet South and 780 feet East; 3 - 2,630 feet South and 1,450 feet East all from NW Corner, Section 30

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-1943

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


4.4 acres NE 1/4 NE 1/4 as projected within Newman DLC 73
3.8 acres NW 1/4 NE 1/4 as projected within Newman DLC 73
Section 25
Township 5 South, Range 1 West, WM

23.5 acres NW 1/4 NW 1/4
35.6 acres NE 1/4 SW 1/4
29.2 acres SE 1/4 SW 1/4
Section 30
Township 5 South, Range 1 East, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
