CERTIFICATE OF WATER RIGHT

This Is to Certify, ThatWALTER M. MATSCHKOWSKY and
RUPERT A. ARCHULETA

of N. Myrtle Road, Box 296, Myrtle Creek, State of Oregon 97457, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of unnamed stream and North Myrtle Creek

a tributary of South Umpqua River for the purpose of domestic use for two families and irrigation of 14.2 acres

under Permit No. 37043 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the rights hereby confirmed dates from July 13, 1972

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second, being 0.01 cfs from unnamed stream for domestic use and 0.18 cfs from creek for irrigation of 14.2 acres

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SE 1/4, NE 1/4 SE 1/4, Section 23, T28S, R4W, WM; unnamed stream - 150 feet South and 2,580 feet West, Creek: Number 4 - 1,130 feet South and 2,490 feet West, Number 2 - 150 feet South and 520 feet West, Number 3 - 610 feet South and 1,240 feet West, all from E 1/4 Corner, Section 23

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


