## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

OREGON STATE PARKS and RECREATION BRANCH

of 525 Trade Street, SE, Salem ,State of Oregon 97310 ,has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of McKenzie River

a tributary of Willamette River
irrigation of 17.0 acres

for the purpose of

under Permit No. 39763 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the rights hereby confirmed dates from July 21, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.21 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $NE\ 1/4\ NE\ 1/4\ as$  projected within Rhea DLC 44, Lot 7 (NW 1/4 NW 1/4), Section 10, T17S, R3W, WM; Diversion 1 - 625 feet North and 2,140 feet East; Diversion 2 - 245 feet North and 2,920 feet East, both from NW Corner, G. Armitage DLC 43.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
