CERTIFICATE OF WATER RIGHT

This Is to Certify, That MT. ANGEL ABBEY

of St. Benedict, State of Oregon 91573, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Abiqua Creek

a tributary of Pudding River for the purpose of irrigation of 161.2 acres

under Permit No. 40232 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 19, 1976 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.02 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, NE 1/4 SW 1/4, both as projected within Allen DLC 50, Section 24, T6S, R1W, WM; Diversion Point 2 - 800 feet North and 700 feet East, Diversion Point 1 - 300 feet South and 2,200 feet East both from W 1/4 Corner, Section 24

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


