of 22633 Riverside Drive, NE, St. Paul , State of Oregon 97137 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willamette River

a tributary of Columbia River
irrigation of 68.1 acres

for the purpose of

under Permit No. 43088 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the rights hereby confirmed dates from April 18, 1978

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.85 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $\frac{1}{4}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within J.B. Deguire DLC 70, Section 1, T4S, R3W, WM; 1,570 feet North and 1,950 feet West from SE Corner, Section 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.7 acres NE 1/4 SW 1/4 as projected within J. B. Deguire DLC 37

6.9 acres NW 1/4 SW 1/4 as projected within J. B. Deguire DLC 37

18.5 acres SW 1/4 SW 1/4 as projected within J. B. Deguire DLC 37

15.3 acres SE 1/4 SW 1/4 as projected within J. B. Deguire DLC 37 Section 6

Township 4 South, Range 2 West, WM

5.5 acres NE 1/4 SE 1/4 as projected within J. B. Deguire DLC 70 16.2 acres SE 1/4 SE 1/4 as projected within J. B. Deguire DLC 70

Section 1 Township 4 South, Range 3 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
