## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** DR. WM. M. and CARR JEAN SOPER

of PO Box 276, Enterprise, State of Kansas 67411, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Simpson Creek

a tributary of Coquille River for the purpose of irrigation of 8.93 acres of cranberry lands

under Permit No. 11966 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the rights hereby confirmed dates from November 18, 1935

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.22 cubic foot per second measured at the point of diversion from the creek,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SE 1/4, Section 20, T28S, R14W, WM; 820 feet South and 980 feet East from C 1/4 Corner, Section 20

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, and shall be further limited not to exceed 6 acre-feet per acre per annum, nor more than 0.75 acre-foot per acre throughout any 30 day period. If for the irrigation of any other crop, this appropriation shall be limited to 1/80 cfs or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.84 acres SW 1/4 SE 1/4  
Section 20  
1.09 acres NW 1/4 NE 1/4  
Section 29  
Township 28 South, Range 14 West, WM


This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered May 26, 1976, as well as to correctly describe the place of use and supersedes Certificate of Water Right recorded on page 11572, Volume 10, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
