of Route 1, Box 237, Enterprise , State of Oregon 97828 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Silver Creek

a tributary of South Fork Wallowa River for the purpose of irrigation of 758.6 acres and supplemental irrigation of 5.0 acres

under Permit No. 582 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 25, 1910

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 9.03 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Silver Creek Ditch, Section 30, T2S, R44E, WM

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to One-eightieth of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
