CERTIFICATE OF WATER RIGHT

This Is to Certify, That

THREE MILE CREEK WATER DITCH COMPANY

of Wamic, State of Oregon 97063, has
 a right to the use of the waters of
 Threemile Creek

a tributary of White River for the purpose of
 irrigation of 132.9 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
 Wasco County, and the said decree entered of record at Salem, in the Order Record of
 the WATER RESOURCES DIRECTOR, in Volume 7, at page 196; that the priority of the
 right thereby confirmed dates from 1870

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
 amount actually beneficially used for said purposes, and shall not exceed three acre-feet
 per acre during any irrigation season (with further limitations contained in
 Paragraph 24 of said decree).

The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 12; NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 10, T4S,
 R11E, WM; Threemile Ditch - 2,550 feet North and 1,250 feet East from SW Corner,
 Section 12; 726 feet South and 528 feet West from NE Corner, Section 10.


This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 7245, Volume 7, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered December 21, 1981, approving Transfer Application 4947.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
