CERTIFICATE OF WATER RIGHT

This Is to Certify, That

W. J. PULLEN

of Route 2, Box 230, Bandon , State of Oregon 97411 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a sump well

a tributary of Spring Creek for the purpose of supplemental irrigation and supplemental supply for frost control and harvesting cranberries of 12.4 acres

under Permit No. G-4266 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 2, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second, being 0.31 cfs for supplemental irrigation, 0.33 cfs for flood harvesting and 0.33 cfs for frost control

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the $\,$ NE 1/4 NE 1/4, Section 20, T28S, R14W, WM; 1,320 feet North and 150 feet West from W 1/4 Corner, Section 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: SUPPLEMENTAL IRRIGATION
