a tributary of Elk Creek

for the purpose of

irrigation of 19.7 acres and domestic use for two families

under Permit No. 38170 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 29, 1973 for irrigation and July 11, 1973 for domestic that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.17 cubic foot per second, being 0.16 cfs for irrigation and 0.01 cfs for domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NE 1/4, NE 1/4 NW 1/4, Section 36, T21S, R5W, WM; Irrigation: 1 - 630 feet South and 1,020 feet East; 2 - 720 feet South and 780 feet East; 3 - 1,080 feet South and 620 feet East; 4 - 1,100 feet South and 350 feet East; 5 - 780 feet South and 100 feet West; 6 - 760 feet South and 500 feet West; 7 - 860 feet South and 890 feet West; 8 - * The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
