CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DAN W. LUFKIN

of Oxbow Ranch, Prairie City , State of Oregon 97869, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Granite Boulder Creek

a tributary of Middle Fork John Day River for the purpose of irrigation of 25.1 acres and supplemental irrigation of 17.6 acres

under Permit No. 43320 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 25, 1978

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.85 cubic foot per second; being 0.63 cfs for irrigation and 0.22 cfs for supplemental irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NE 1/4, SE 1/4 SW 1/4, SE 1/4, SE 1/4 SW 1/4, SE 1/3, R34E, WM; 660 feet North and 200 feet East from Center, Section 32, 1,140 feet North and 1,440 feet East from SW Corner, Section 32

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5 acre-feet per acre for each acre irrigated during the irrigation season of each year provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
