CERTIFICATE OF WATER RIGHT

This Is to Certify, That

AGNES M. WEBB

of Route 1, Box 94, Tygh Valley , State of Oregon 97063 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Buck Hollow Creek, Kerr Creek, and Webb Reservoir constructed under Permit R-6150

a tributary of Descrutes River for the purpose of irrigation of 11.9 acres and supplemental irrigation of 7.4 acres

under Permit No. 38057 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 10, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.48 cubic foot per second, being 0.16 cfs from Buck Hollow Creek and 0.32 cfs from Kerr Creek and reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 NW 1/4, SW 1/4 NE 1/4, Section 2, T4S, R14E, WM; Buck Hollow Creek – 180 feet South and 2,660 feet West, Kerr Creek – 1,850 feet South and 2,520 feet West both from NE Corner, Section 2

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from Webb Reservoir constructed under Permit R-6150

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
