CERTIFICATE OF WATER RIGHT

This Is to Certify, That W. J. PULLEN

of Route 2, Box 230, Bandon, State of Oregon 97411, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Spring Creek with any deficiency in the available supply from Spring Creek to be made up by appropriation from an unnamed stream a tributary of*

a tributary of Coquille River for the purpose of irrigation of 9.2 acres, supplemental irrigation of 3.2 acres, and frost control and harvesting cranberries of 12.4 acres

under Permit No. 34059 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 2, 1968

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cfs; being 0.25 cfs for irrigation, 0.33 cfs for frost control and 0.33 cfs for harvesting cranberries from creeks, 0.9 acre-foot for supplemental irrigation and 0.9 acre-foot for harvesting cranberries from reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NW 1/4, NW 1/4 SW 1/4, Section 21, T28S, R14W, WM; Spring Creek - 1,420 feet North and 170 feet East; Simpson Creek and reservoir - 580 feet South and 20 feet East, both from W 1/4 Corner, Section 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre,

or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year and shall be further limited to the use of stored water** and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

* Simpson Creek, provided that the total quantity diverted from both sources shall not exceed 0.33 cubic foot per second and 0.9 acre-foot for harvesting cranberries and 0.9 acre-foot for supplemental irrigation from Pullen Reservoir constructed under Permit R-5402

** only on the lands described as supplemental.


