under Permit No. 41623 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 15, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 222.53 acre-feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NW 1/4, NE 1/4 SW 1/4, Section 6, T13S, R4W, WM; Diversion 14 - 1,900 feet North and 700 feet East; Diversion 18 - 120 feet South and 2,060 feet East, both from the W 1/4 Corner, Section 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to -----of one-cubic-foot per-second per were,----a diversion of 2 1/2 acre-feet for each acre irrigated during the irrigation season of each year and is subject to the terms and conditions of Contract 7-07-10-W0058, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department
