CERTIFICATE OF WATER RIGHT

This Is to Certify, *That* ROBERT L. RICKERT

of 5760 NE, Highway 20, Corvallis, State of Oregon 97330, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well

a tributary of Willamette River for the purpose of irrigation of 87.5 acres

under Permit No. G-7201 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 18, 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.0 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 SW 1/4 as projected within Hunter DLC 43, Section 9, T11S, R4W, WM; 3,330 feet South and 510 feet East from NW Corner, Section 9

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.2 acre NE 1/4 NE 1/4 as projected within Roberts DLC 41
 2.8 acres SE 1/4 NE 1/4 as projected within Hunter DLC 43
 4.0 acres NE 1/4 SE 1/4 as projected within Hunter DLC 43
 0.3 acre SE 1/4 SE 1/4 as projected within Hunter DLC 43
 Section 8


18.0 acres NW 1/4 NW 1/4 as projected within Roberts DLC 41
 32.0 acres SW 1/4 NW 1/4 as projected within Hunter DLC 43
 0.1 acre NE 1/4 SW 1/4 as projected within Hunter DLC 43
 30.0 acres NW 1/4 SW 1/4 as projected within Hunter DLC 43
 0.1 acre SW 1/4 SW 1/4 as projected within Hunter DLC 43
