under Permit No. G-4432 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

November 18, 1968 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.75 cubic foot per second, being 0.25 cfs from each well

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW 1/4 NW 1/4, Section 23, SW 1/4 SW 1/4, NW 1/4, NW 1/4, Section 22, T18S, R41E, WM; Well 1-3,830 feet North and 600 feet East from SW Corner, Section 23; Well 2-130 feet North and 100 feet East from SW Corner, Section 22; Well 3-210 feet South and 340 feet East from NW Corner, Section 22

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the amount of water rediverted from the channel of Bully Creek and Dry Creek shall not exceed the amount by which the flow of Bully and Dry Creeks at the points of rediversion is increased above the natural flow by the operation of said wells

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
