and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Malheur County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8, at page 228; that the priority of the right thereby confirmed dates from 1876 for Tract 2 and 1883 for Tract 3;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half acre feet per acre in any 30-day period prior to June 1, one acre foot per acre in any 30-day period after June 1 of each year, or three acre feet per acre in any season, diverted at a rate not to exceed one-twentieth of a cubic*

The point of diversion is located in the SE 1/4 NE 1/4, Section 25, T18S, R41E, WM; 1,860 feet South and 410 feet West from NE Corner, Section 25;
