CERTIFICATE OF WATER RIGHT

This Is to Certify, That

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Malheur County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8 , at page 228; that the priority of the right thereby confirmed dates from 1886;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half acre feet per acre in any 30-day period prior to June 1, one acre foot per acre in any 30-day period after June 1 of each year, or three acre feet per acre in any season, diverted at a rate not to exceed one-twentieth of a cubic foot per second per acre.

The point of diversion is located in the NE 1/4 NW 1/4, Section 27, NW 1/4 SE 1/4, Section 26, T18S, R41E, WM; 1,120 feet South and 2,130 feet East from NW Corner, Section 27; 1,400 feet North and 2,030 feet West from SE Corner, Section 26.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

- 34.0 acres SE 1/4 SE 1/4
Section 26
 - 3.0 acres SW 1/4 NW 1/4
 - 4.0 acres SE 1/4 NW 1/4
 - 26.5 acres NW 1/4 SW 1/4
 - 24.5 acres SW 1/4 SW 1/4


This certificate is issued to confirm an additional point of diversion approved by an order of the Water Resources Director entered November 29, 1978 and together with certificates of water right recorded at pages 51106 and 51105 , Volume 45, State Record of Water Right Certificates, supersedes certificate of water right recorded at page 7055, Volume 7, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
