CERTIFICATE OF WATER RIGHT

of 4355 Turner, Road, SE, Salem , State of Oregon 9730l , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Fork Indian Creek and Vaughan Reservoir constructed under Permit R-2076

a tributary of Malheur River for the purpose of irrigation of 26.5 acres and supplemental irrigation of 257.7 acres

under Permit No. 25134 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 24, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.66 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NE 1/4, Section 15, NW 1/4 SW 1/4, Section 13, T18S, R39E, WM; SE 1/4 NW 1/4, Section 18, T18S, R40E, WM; Reservoir - 2,450 feet South and 420 feet West from NE Corner, Section 15; Stream - 2,480 feet North and 334 feet East from SW Corner, Section 13, 1,440 feet South and 1,550 feet East from NW Corner, Section 18

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow for lands described as primary and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-2076; and further limited to the use of stored water only on lands described as supplemental

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
