that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.30 cubic foot per second; being 0.04 cfs for school use and 0.26 cfs for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE 1/4 NW 1/4; NW 1/4 SE 1/4 as projected within E. Bristow DLC 69; NW 1/4 SE 1/4 as projected within Gilfillan DLC 53, Section 34, T18S, R2W, WM; Well 5 - 2,300 feet North and 1,280 feet West; Well 4 - 1,900 feet North and 330 feet West; Well 3 - 1,530 feet North and 150 feet West; Well 2 - 970 feet North and 620 feet West; Well 1 - 1,000 feet North and*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year;

conform to such reasonable rotation system as may be ordered by the proper state officer.
