## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** FLOYD VENABLE

of 6355 Blackwell Road, Central Point, State of Oregon 97501, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Bear Creek

a tributary of Rogue River for the purpose of irrigation of 20.0 acres

under Permit No. 1502 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 25, 1913

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second, if available at the original point of diversion, NE 1/4 NW 1/4, Section 28, T36S, R2W, WM; 577 feet South and 1,775 feet East from NW Corner, Section 28

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NE 1/4 as projected within Hall DLC 50, NE 1/4 NW 1/4, as projected within Hall DLC 50, Section 28, T36S, R2W, WM; Tract 1 - 730 feet South and 2,120 feet West from NE Corner, Section 28; Tract 2 - 230 feet South and 1,430 feet East from NW Corner, Section 28

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


This certificate is issued to confirm a change in place of use and point of diversion approved by an order of the Water Resources Director entered January 28, 1974 and together with Certificate of Water Right recorded at page 40380, Volume 32, State Record of Water Right Certificates, supersedes Certificate 2315.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board*
