CERTIFICATE OF WATER RIGHT

This Is to Certify, That NORTH JAMIESON FARMS, INC.

of % Dean Barlow, Vale, State of Oregon 97918, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of three wells

a tributary of Willow Creek for the purpose of supplemental irrigation of 113.2 acres

under Permit No. U-446 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 29, 1950 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.41 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ & NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 4, T16S, R43E, WM; 190 feet south and 570 feet east, 2,640 feet south and 40 feet east, and 1,270 feet south and 40 feet east from NW Corner, Section 4, T16S, R43E, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre NE $\frac{1}{4}$ NW $\frac{1}{4}$	28.4 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
36.8 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$	16.4 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$
28.8 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$	Section 4
2.0 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$	Township 16 South, Range 43 East, WM


