CERTIFICATE OF WATER RIGHT

This Is to Certify, That

W. BRYAN WOLFE STEPHEN D. WOLFE DWIGHT E. WOLFE

of Route 2, Box 2743, Hermiston , State of Oregon 97838 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of two wells

a tributary of Columbia River for the purpose of irrigation of 277.7 acres and supplemental irrigation of 35.0 acres

under Permit No. G-5763 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 16, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.85 cubic feet per second; being 0.35 cfs from Well 1 and 3.50 cfs from Well 2

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW 1/4 SW 1/4, Section 19; SW 1/4 NW 1/4, Section 30, T5N, R29E, WM; Well 1 - 700 feet North and 510 feet East from SW Corner, Section 19; Well 2 - 2,080 feet South and 45 feet East from NW Corner, Section 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
