## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**

JOHN M. AND MARGUERITE W. BLACK

of 4513 Forest Creek Road, Jacksonville, State of Oregon 97530, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Oregon Belle Fork Creek and Left Fork Forest Creek

a tributary of Applegate River for the purpose of irrigation of 18.6 acres

under Permit No. 29657 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 5, 1964 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.46 cubic foot per second measured at the points of diversion, being 0.39 cfs from Oregon Belle Fork Creek and 0.07 from Left Fork Forest Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SE 1/4, Section 32, T37S, R3W, WM; Diversion 1 - 320 feet North and 80 feet East from S 1/4 Corner, Section 32, NE 1/4 SW 1/4, Section 5, T38S, R3W, WM; 160 feet South and 1,690 feet East from W 1/4 Corner, Section 5

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


