CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That B. F. ALLEN  
 of Prineville State of Oregon has a right to the use of  
 the waters of McKay Creek, a tributary of Crooked River

for the purpose of the irrigation of 255 acres of land, and stock and domestic use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Crook County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 1, at page 449 ; that the priority of the right hereby confirmed dates from 1896 for Tract 1, 1907 for Tract 2, 1891 for Tract 3, 1889 for Tract 4, 1896 for Tract 5, 1897 for Tract 6 and 1899 for Tract 7, described below,

that the amount of water to which such right is entitled and hereby confirmed for the purpose aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed a reasonable amount for domestic and stock use, and 3.21 cubic feet per second for irrigation, the total quantity being limited to four acre feet per acre during each year. The use hereunder shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

- Tract No. 1, 42 acres located as follows: 24 ac. SE $\frac{1}{4}$ NW $\frac{1}{4}$ ; 18 ac. NE $\frac{1}{4}$ SW $\frac{1}{4}$ ; Sec. 33, Tp. 13 S. R. 16 E. W. M., in Crook County, Oregon.
- Tract No. 2, 19 acres located as follows: 3 ac. SW $\frac{1}{4}$ NE $\frac{1}{4}$ ; 16 ac. NW $\frac{1}{4}$ SE $\frac{1}{4}$ ; Sec. 33, Tp. 13 S. R. 16 E. W. M., in Crook County, Oregon.
- Tract No. 3, 24 acres located as follows: 9 ac. NW $\frac{1}{4}$ NE $\frac{1}{4}$ ; 15 ac. SW $\frac{1}{4}$ NE $\frac{1}{4}$ ; Sec. 28, Tp. 13 S. R. 16 E. W. M., in Crook County, Oregon.
- Tract No. 4, 85 acres located as follows: 5 ac. NE $\frac{1}{4}$ SE $\frac{1}{4}$ ; 1 ac. SW $\frac{1}{4}$ SE $\frac{1}{4}$ ; 24 ac. SE $\frac{1}{4}$ SE $\frac{1}{4}$ ; Sec. 5: 8 ac. NW $\frac{1}{4}$ SW $\frac{1}{4}$ ; Sec. 4: 20 ac. NE $\frac{1}{4}$ NE $\frac{1}{4}$ ; 27 ac. NW $\frac{1}{4}$ NE $\frac{1}{4}$ ; Sec. 8: all in Tp. 14 S. R. 16 E. W. M., in Crook County, Oregon.
- Tract No. 5, 5 acres located as follows: 5 ac. NW $\frac{1}{4}$ NW $\frac{1}{4}$ ; Sec. 9, Tp. 14 S. R. 16 E. W. M., in Crook County, Oregon.
- Tract No. 6, 36 acres located as follows: 13 ac. NW $\frac{1}{4}$ SE $\frac{1}{4}$ ; 21 ac. SW $\frac{1}{4}$ SE $\frac{1}{4}$ ; 2 ac. SE $\frac{1}{4}$ SE $\frac{1}{4}$ ; Sec. 21, Tp. 13 S. R. 16 E. W. M., in Crook County, Oregon.
- Tract No. 7, 44 acres located as follows: 11 ac. SE $\frac{1}{4}$ SE $\frac{1}{4}$ ; Sec. 28: 13 ac. NE $\frac{1}{4}$ NE $\frac{1}{4}$ ; 20 ac. SW $\frac{1}{4}$ NE $\frac{1}{4}$ ; Sec. 33: all in Tp. 13 S. R. 16 E. W. M., in Crook County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
