CERTIFICATE OF WATER RIGHT

a tributary of Pacific Ocean irrigation of 1168.26 acres

for the purpose of

under Permit No. 8888 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 29, 1916 for 10 cfs and October 10, 1916 for 4.59925 cfs that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 14.59925 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $1/4\,$ NE $1/4,\,$ Section 11, T36S, R3W, WM; North 38 degrees East, 4,900 feet from the SW Corner, Section 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.
